User reports are processed by our Safety team for violative behavior so we can take enforcement actions where appropriate. When we see content that violates our policies, we take the appropriate action based on the severity of the violation. The result of our actions are conveyed to users through our Warning System and include:</p> <ul style="list-style-type: none"> · Warning to the user that future violations may result in more severe consequences; · Restricting user access to features (e.g., inability to send images on Discord after sending an image that violated a Discord policy); · Content removal; · Temporary suspension of user account; · Permanent ban of user account. <p>When a server is focused on or contains a lot of content that violates our policies, the owner of the server will receive a violation and the server may be removed or restricted. Just like user violations, the server owner will be provided a summary of the violation with more detail.</p> <p>Discord is also committed to working with industry partners and other organizations to support its safety efforts. Our Safety Reporting Network features a global partnership of trusted organizations who collaborate directly with Discord's Safety team. Discord also contributes to and participates in industry-wide efforts such as the Lantern initiative, a first-of-its-kind signal sharing program for companies to enhance and strengthen how they detect attempts to sexually exploit and abuse children and teens online.</p>
